

Planning Committee Meeting Minutes

Meeting held in the Village Hall, Recreation Ground, Cottenham on Thursday 7th December 2017 at 7.30pm

Present: Cllrs Mudd (Chair), Collinson, Graves, Nicholas, Smith, Ward, Wilson, Young and the Clerk **In attendance:** 2 members of the public

- **17P/219.** Chairman's Introduction and Apologies Apologies accepted from Cllrs Bolitho (personal) and Morris (meeting).
- 17P/220. Any Questions from the Public or Press Standing orders suspended 7.34pm. Resident 1 spoke regarding item 17P/226. Requested working party to investigate. Not expecting financial input from the Parish Council. SCDC has said they can only clear part of the tipping (from public land). Resident would be happy to meet with Cllrs and get some of the travellers involved. Currently the site is an eyesore and a health hazard as well as the potential for flooding. Cllr Ward asked if the tipping was on private land. Resident 1 confirmed it was both private and public land. Some of the ditches may belong to Old West Internal Drainage Board (OWIDB). SCDC still haven't actioned the fly tipping despite being notified several weeks ago. Resident 2 didn't want to raise any matters. Standing Orders reinstated 7.37pm.
- **17P/221.** To accept Declarations of Interest and Dispensations Cllr Smith declared an interest in application S/4022/17/OL and will take no part in discussions. Cllr Mudd declared an interest in application S/4126/17/FL and will take no part in discussions.
- **17P/222. Minutes** Resolution that the minutes of the Committee meeting held on 23rd November 2017 be signed as a correct record. **RESOLVED**.
- 17P/226. Fly tipping Consider working party to visit Setchell Drove area with resident(s) with a view to working with other authorities to get the area to an acceptable standard (item previously deferred) Item brought forward. Noted that SCDC has a duty to clear fly tipping from public land; on private land they can issue a notice to the owner to clear. Standing Orders suspended 7.40pm. Resident 1 confirmed that gating and CCTV has been suggested to prevent issues. Standing Orders reinstated 7.41pm. Cllr Graves confirmed that there are no OWIDB ditches in the vicinity. Regarding the legalities, suspect that Setchell Drove is like Long Drove where the land was owned 50/50 by landowners and then adopted. Standing Orders suspended 8.45pm. Resident 1 confirmed there are 3 owners in the area. Bigger issue with the drainage; one of the drains goes into an OWIDB drain. Standing Orders reinstated 8.46pm. Resolution to set up working party to visit Setchell Drove with residents. RESOLVED. Members are: Cllrs Collinson, Graves, Mudd, Nicholas, Smith and Wilson. Clerk to contact Chris Bradley at SCDC with a view to attending.

17P/223. Planning Applications:

- S/4022/17/OL Application for outline planning permission for residential development with all
 matters reserved apart from access, 17 Orchard Close, Cottenham. Access considered too close to
 existing property and would remove pedestrian access to no. 17, therefore causing loss of amenity
 (DP3/2j). CPC recommends refusal. REFUSED.
- **S/4026/17/FL** New garage and car port (following demoltion of existing garage), 17 Telegraph Street, Cottenham. CPC recommends approval. **APPROVED**.
- **S/4129/17/FL** Remove existing shed and replace with larger timber shed, 54 Pelham Close Cottenham. CPC recommend approval. **APPROVED**.
- **S/4126/17/FL** Single storey rear extension, 14 The Linnets, Cottenham. Cllr Young took the Chair and read out the reason why the previous Lawful Development application was refused. Noted that application didn't mention addition of chimney but refusal was based on the extension only. CPC recommends approval. **APPROVED**.
- **S/4020/17/FL** to replace 16 windows and the front door of property, 2 Bramley Close, Cottenham. Cllr Mudd returned to the Chair. CPC recommends approval. **APPROVED**.
