

## Cottenham Parish Council –Financial Regulations – February 2018

### 1 General

New Ref	Based on NALC 2016 text (with amendments by FLAC)
1.1	<p>These financial regulations govern the conduct of financial management by the council and may only be amended or varied by resolution of the council.</p> <p>Financial regulations are one of the council's three governing policy documents providing procedural guidance for members and officers.</p> <p>Financial regulations must be observed in conjunction with the council's standing orders and any individual financial regulations relating to contracts.</p>
1.2	The council is responsible in law for ensuring that its financial management is adequate and effective and that the council has a sound system of internal control which facilitates the effective exercise of the council's functions, including arrangements for the management of risk
1.3	<p>The council's accounting control systems must include measures:</p> <ul style="list-style-type: none"> <li>• for the timely production of accounts;</li> <li>• that provide for the safe and efficient safeguarding of public money;</li> <li>• to prevent and detect inaccuracy and fraud; and</li> <li>• identifying the duties of officers.</li> </ul>
1.4	These financial regulations demonstrate how the council meets these responsibilities and requirements.
1.5	At least once a year, prior to approving the Annual Governance Statement, the council must review the effectiveness of its system of internal control which shall be in accordance with proper practices.
1.6	Deliberate or wilful breach of these Regulations by an employee may give rise to disciplinary proceedings.
1.7	<p>Members of Council are expected to follow the instructions within these Regulations and not to entice employees to breach them.</p> <p>Failure to follow instructions within these Regulations brings the office of councillor into disrepute</p>
1.8	The Responsible Financial Officer (RFO) holds a statutory office to be appointed by the council

1.9	<p>The RFO;</p> <ul style="list-style-type: none"> <li>• acts under the policy direction of the council;</li> <li>• administers the council's financial affairs in accordance with all Acts, Regulations and proper practices;</li> <li>• determines on behalf of the council its accounting records and accounting control systems;</li> <li>• ensures the accounting control systems are observed;</li> <li>• maintains the accounting records of the council up to date in accordance with proper practices;</li> <li>• assists the council to secure economy, efficiency and effectiveness in the use of its resources; and</li> <li>• produces financial management information as required by the council</li> </ul>
1.10	<p>The accounting records determined by the RFO shall be sufficient to show and explain the council's transactions and to enable the RFO to ensure that any income and expenditure account and statement of balances, or record of receipts and payments and additional information, as the case may be, or management information prepared for the council from time to time comply with the Accounts and Audit Regulations.</p>
1.11	<p>The accounting records determined by the RFO shall in particular contain:</p> <ul style="list-style-type: none"> <li>• entries from day to day of all sums of money received and expended by the council and the matters to which the income and expenditure or receipts and payments account relate;</li> <li>• a record of the assets and liabilities of the council; and</li> <li>• wherever relevant, a record of the council's income and expenditure in relation to claims made, or to be made, for any contribution, grant or subsidy.</li> </ul>
1.12	<p>The accounting control systems determined by the RFO shall include:</p> <ul style="list-style-type: none"> <li>• procedures to ensure that the financial transactions of the council are recorded as soon as reasonably practicable and as accurately and reasonably as possible;</li> <li>• procedures to enable the prevention and detection of inaccuracies and fraud and the ability to reconstruct any lost records;</li> <li>• identification of the duties of officers dealing with financial transactions and division of responsibilities of those officers in relation to significant transactions;</li> <li>• procedures to ensure that uncollectable amounts, including any bad debts are not submitted to the council for approval to be written off except with the approval of the RFO and that the approvals are shown in the accounting records; and</li> <li>• measures to ensure that risk is properly managed.</li> </ul>

1.13	<p>The council is not empowered by these Regulations or otherwise to delegate certain specified decisions. In particular any decision regarding:</p> <ul style="list-style-type: none"><li>• setting the final budget or the precept (council tax requirement);</li><li>• approving accounting statements;</li><li>• approving an annual governance statement;</li><li>• borrowing;</li><li>• writing off bad debts;</li><li>• declaring eligibility for the General Power of Competence; and</li><li>• addressing recommendations in any report from the internal or external auditors,</li></ul> <p>shall be a matter for the full council only.</p>
1.14	<p>In addition the council must:</p> <ul style="list-style-type: none"><li>• determine and keep under regular review the bank mandate for all council bank accounts;</li><li>• approve any grant or a single commitment in excess of £5,000 and</li><li>• in respect of the annual salary for any employee have regard to recommendations about annual salaries of employees made by the relevant committee in accordance with its terms of reference.</li></ul>
1.15	<p>In these financial regulations, references to the Accounts and Audit Regulations or ‘the regulations’ shall mean the regulations issued under the provisions of section 27 of the Audit Commission Act 1998, or any superseding legislation, and then in force unless otherwise specified.</p> <p>In these financial regulations the term ‘proper practice’ or ‘proper practices’ shall refer to guidance issued in <i>Governance and Accountability for Local Councils - a Practitioners’ Guide (England)</i> issued by the Joint Practitioners Advisory Group (JPAG), available from the websites of NALC and the Society for Local Council Clerks (SLCC).</p>

### 2 Accounting & Audit

New Ref	Based on NALC 2016 text (with amendments by FLAC)
2.1	All accounting procedures and financial records of the council shall be determined by the RFO in accordance with the Accounts and Audit Regulations, appropriate guidance and proper practices.
2.2	<p>On a regular basis, at least once in each quarter, and at each financial year end, a member other than the Chair or a cheque signatory shall be appointed to verify bank reconciliations (for all accounts) produced by the RFO unless there are extenuating circumstances.</p> <p>The member shall sign the reconciliations and the original bank statements (or similar document) as evidence of verification. This activity shall on conclusion be reported, including any exceptions, to and noted by, FLAC. Exceptions must be reported to Council.</p>
2.3	The RFO shall complete the annual statement of accounts, annual report, and any related documents of the council contained in the Annual Return (as specified in proper practices) as soon as practicable after the end of the financial year and having certified the accounts shall submit them and report thereon to the council within the timescales set by the Accounts and Audit Regulations
2.4	<p>FLAC, on behalf of the council, shall ensure that there is an adequate and effective system of internal audit of its accounting records, and of its system of internal control in accordance with proper practices.</p> <p>Any officer or member of the council shall make available such documents and records as appear to the council to be necessary for the purpose of the audit and shall, as directed by the council, supply the RFO, internal auditor, or external auditor with such information and explanation as the council considers necessary for that purpose.</p>
2.5	The internal auditor shall be appointed by and shall carry out the work in relation to internal controls required by the council in accordance with proper practices
2.6	<p>The internal auditor shall:</p> <ul style="list-style-type: none"> <li>• be competent and independent of the financial operations of the council;</li> <li>• report to council in writing, or in person, on a regular basis with a minimum of one annual written report during each financial year;</li> <li>• to demonstrate competence, objectivity and independence, be free from any actual or perceived conflicts of interest, including those arising from family relationships; and</li> <li>• have no involvement in the financial decision making, management or control of the council.</li> </ul>
2.7	<p>Internal or external auditors may not under any circumstances:</p> <ul style="list-style-type: none"> <li>• perform any operational duties for the council;</li> <li>• initiate or approve accounting transactions; or</li> <li>• direct the activities of any council employee, except to the extent that such employees have been appropriately assigned to assist the internal auditor.</li> </ul>

2.8	For the avoidance of doubt, in relation to internal audit the terms ‘independent’ and ‘independence’ shall have the same meaning as is described in proper practices.
2.9	The RFO shall make arrangements for the exercise of electors’ rights in relation to the accounts including the opportunity to inspect the accounts, books, and vouchers and display or publish any notices and statements of account required by Audit Commission Act 1998, or any superseding legislation, and the Accounts and Audit Regulations.
2.10	The RFO shall, without undue delay, bring to the attention of all councillors any correspondence or report from internal or external auditors.

### 3 Annual Estimates (Budget) & Forward Planning

New Ref	Based on NALC 2016 text (with amendments by FLAC)
3.1	Each committee shall review its three year forecast of revenue and capital receipts and payments. Having regard to the forecast, it shall thereafter formulate and submit proposals for the following financial year to the council not later than the end of October each year including any proposals for revising the forecast.
3.2	The RFO must each year, by no later than end of December, prepare detailed estimates of all receipts and payments including the use of reserves and all sources of funding for the following financial year in the form of a budget to be considered by the FLAC and the council.
3.3	FLAC shall consider annual budget proposals in relation to the council's three year forecast of revenue and capital receipts and payments including recommendations for the use of reserves and sources of funding and update the forecast accordingly.
3.4	The council shall fix the precept (council tax requirement), and relevant basic amount of council tax to be levied for the ensuing financial year not later than by the end of January each year.  The RFO shall issue the precept to the billing authority and shall supply each member with a copy of the approved annual budget.
3.5	The approved annual budget shall form the basis of financial control for the ensuing year.

### 4 Budgetary Control & Authority to Spend

New Ref	Based on NALC 2016 text (with amendments by FLAC)
4.1	<p>Expenditure on revenue items may be authorised up to the amounts included for that class of expenditure in the approved budget.</p> <p>This authority is to be determined by:</p> <ul style="list-style-type: none"> <li>• the council for all items over £5,000;</li> <li>• a duly delegated committee of the council for items over £500; or</li> <li>• the Clerk, in conjunction with Chair of Council or Chair of the appropriate committee, for any items below £500 and above £100</li> <li>• The Clerk for any item below £100</li> </ul> <p>Such authority is to be evidenced by a minute or by an authorisation slip duly signed by the Clerk, and where necessary also by the appropriate Chair.</p> <p>Contracts may not be disaggregated to avoid controls imposed by these regulations.</p>
4.2	<p>No expenditure may be authorised that will exceed the amount provided in the revenue budget for that class of expenditure other than by resolution of the council.</p> <p>During the budget year and with the approval of council having considered fully the implications for public services, unspent and available amounts may be moved to other budget headings or to an earmarked reserve as appropriate ('virement').</p>
4.3	<p>Unspent provisions in the revenue or capital budgets for completed projects shall not be carried forward to a subsequent year.</p>
4.4	<p>The salary budgets are to be reviewed at least annually in October for the following financial year and such review shall be evidenced by a hard copy schedule signed by the Clerk and the Chair of Council or relevant committee. The RFO will inform committees of any changes impacting on their budget requirement for the coming year in good time.</p>
4.5	<p>In cases of extreme urgency, the clerk may authorise revenue expenditure on behalf of the council which in the clerk's judgement it is necessary to carry out.</p> <p>Such expenditure includes repair, replacement or other work, whether or not there is any budgetary provision for the expenditure, subject to a limit of £3,000.</p> <p>The Clerk shall report such action to the Chair as soon as possible and to the council as soon as practicable thereafter.</p>
4.6	<p>No expenditure shall be authorised in relation to any capital project and no contract entered into or tender accepted involving capital expenditure unless the council is satisfied that the necessary funds are available and the requisite borrowing approval has been obtained</p>
4.7	<p>All capital works shall be administered in accordance with the council's standing orders and financial regulations relating to contracts.</p>

4.8	<p>The RFO shall quarterly provide the council with a statement of receipts and payments to date under each head of the budgets, comparing actual expenditure to the appropriate date against that planned as shown in the budget.</p> <p>These statements are to be prepared at least at the end of each financial quarter and shall show explanations of material variances. For this purpose “material” shall be in excess of £500 or 15% of the budget.</p>
4.9	<p>Changes in earmarked reserves shall be approved by council as part of the budgetary control process.</p>

### 5 Banking Arrangements & authorisation of Payments

New Ref	Based on NALC 2016 text (with amendments by FLAC)
5.1	The council's banking arrangements, including the bank mandate, shall be made by the RFO and approved by the council; banking arrangements may not be delegated to a committee. They shall be annually reviewed for safety and efficiency.
5.2	<p>The RFO shall prepare a schedule of payments requiring authorisation, forming part of the Agenda for the Meeting and, together with the relevant invoices, present the schedule to council.</p> <p>The council shall review the schedule for compliance and, having satisfied itself shall authorise payment by a resolution of the council. The approved schedule shall be ruled off and initialled by the Chair of the Meeting.</p> <p>A detailed list of all payments shall be disclosed within or as an attachment to the minutes of the meeting at which payment was authorised. Personal payments (including salaries, wages, expenses and any payment made in relation to the termination of a contract of employment) may be summarised to remove public access to any personal information</p>
5.3	All invoices for payment shall be examined, verified and certified by the RFO to confirm that the work, goods or services to which each invoice relates has been received, carried out, examined and represents expenditure previously approved by the council
5.4	<p>The RFO shall examine invoices for arithmetical accuracy and analyse them to the appropriate expenditure heading.</p> <p>The RFO shall take all steps to pay all invoices submitted, and which are in order, at the next available council or committee meeting</p>
5.5	<p>The Clerk and RFO shall have delegated authority to authorise the payment of items only in the following circumstances:</p> <ul style="list-style-type: none"> <li>• If a payment is necessary to avoid a charge to interest under the Late Payment of Commercial Debts (Interest) Act 1998, and the due date for payment is before the next scheduled Meeting of council, where the Clerk and RFO certify that there is no dispute or other reason to delay payment, provided that a list of such payments shall be submitted to the next appropriate meeting of council</li> <li>• An expenditure item authorised under 5.6 below (continuing contracts and obligations) provided that a list of such payments shall be submitted to the next appropriate meeting of council or</li> <li>• fund transfers within the councils banking arrangements up to the sum of £10,000, provided that a list of such payments shall be submitted to the next appropriate meeting of council.</li> </ul>
5.6	For each financial year the Clerk and RFO shall draw up a list of due payments which arise on a regular basis as the result of a continuing contract, statutory duty, or obligation (such as but not exclusively, Salaries, PAYE and NI, Superannuation Fund and regular maintenance contracts and the like for which council may authorise payment for the year provided that the requirements of regulation 4.1 (Budgetary Controls) are adhered to, provided also that a list of such payments shall be submitted to the next appropriate meeting of council.

5.7	A record of regular payments made under 5.6 above shall be drawn up and be signed by two members - thus controlling the risk of duplicated payments being authorised and / or made.
5.8	In respect of grants made by CPC a duly authorised committee shall approve expenditure within any limits set by council and in accordance with any policy statement approved by council.  Any Revenue or Capital Grant in excess of £5,000 shall before payment, be subject to ratification by resolution of the council.
5.9	Members are subject to the Code of Conduct that has been adopted by the council and shall comply with the Code and Standing Orders when a decision to authorise or instruct payment is made in respect of a matter in which they have a disclosable pecuniary or other interest, unless a dispensation has been granted.
5.10	The council will aim to rotate the duties of members in these Regulations so that onerous duties are shared out as evenly as possible over time.
5.11	Any changes in the recorded details of suppliers, such as bank account records, shall be approved in writing by a Member.

### 6 Instructions for Making Payments

New Ref	Based on NALC 2016 text (with amendments by FLAC)
6.1	The council will make safe and efficient arrangements for the making of its payments
6.2	Following authorisation under Financial Regulation 5 above, the council, a duly delegated committee or, if so delegated, the Clerk or RFO shall give instruction that a payment shall be made
6.3	All payments shall be effected by cheque or other instructions to the council's bankers, or otherwise, in accordance with a resolution of council.
6.4	<p>Cheques or orders for payment drawn on the bank account in accordance with the schedule as presented to council or committee shall be signed by two members of council in accordance with a resolution instructing that payment.</p> <p>If a member who is also a bank signatory has declared a disclosable pecuniary interest, or has any other interest, in the matter in respect of which the payment is being made, that councillor shall be required to consider Standing Orders, and thereby determine whether it is appropriate and / or permissible to be a signatory to the transaction in question</p>
6.5	To indicate agreement of the details shown on the cheque or order for payment with the counterfoil and the invoice or similar documentation, the signatories shall each also initial the cheque counterfoil
6.6	<p>Cheques or orders for payment shall not normally be presented for signature other than at a council or committee meeting (including immediately after such a meeting).</p> <p>Any signatures obtained away from such meetings shall be reported to the council at the next convenient meeting</p>
6.7	<p>If thought appropriate by the council, payment for utility supplies (energy, telephone and water) and any National Non-Domestic Rates may be made by variable direct debit provided that the instructions are signed by two members and any payments are reported to council as made.</p> <p>The approval of the use of a variable direct debit shall be renewed by resolution of the council at least every two years</p>
6.8	<p>If thought appropriate by the council, payment for certain items (principally salaries) may be made by banker's standing order provided that the instructions are signed, or otherwise evidenced by two members are retained and any payments are reported to council as made.</p> <p>The approval of the use of a banker's standing order shall be renewed by resolution of the council at least every two years</p>
6.9	<p>If thought appropriate by the council, payment for certain items may be made by BACS or CHAPS methods provided that the instructions for each payment are signed, or otherwise evidenced, by two authorised bank signatories are retained and any payments are reported to council as made.</p> <p>The approval of the use of BACS or CHAPS shall be renewed by resolution of the council at least every two years</p>

6.10	If thought appropriate by the council payment for certain items may be made by internet banking transfer provided evidence is retained showing which members approved the payment
6.11	<p>Where a computer requires use of a personal identification number (PIN) or other password(s), for access to the council's records on that computer, a note shall be made of the PIN and Passwords and shall be handed to and retained by the Chair of Council in a sealed dated envelope.</p> <p>This envelope may not be opened other than in the presence of two other councillors.</p> <p>After the envelope has been opened, in any circumstances, the PIN and / or passwords shall be changed as soon as practicable.</p> <p>The fact that the sealed envelope has been opened, in whatever circumstances, shall be reported to all members immediately and formally to the next available meeting of the council.</p> <p>This will not be required for a member's personal computer used only for remote authorisation of bank payments</p>
6.12	No employee or councillor shall disclose any PIN or password, relevant to the working of the council or its bank accounts, to any person not authorised in writing by the council or a duly delegated committee
6.13	Regular back-up copies of the records on any computer shall be made and shall be stored securely away from the computer in question, and preferably off site
6.14	The council, and any members using computers for the council's financial business, shall ensure that anti-virus, anti-spyware and firewall, software with automatic updates, together with a high level of security, is used
6.15	Where internet banking arrangements are made with any bank, the RFO shall be appointed as the Service Administrator. The bank mandate approved by the council shall identify a number of councillors who will be authorised to approve transactions on those accounts. The bank mandate will state clearly the amounts of payments that can be instructed by the use of the Service Administrator alone, or by the Service Administrator with a stated number of approvals
6.16	Access to any internet banking accounts will be directly to the access page (which may be saved under "favourites"), and not through a search engine or e-mail link. Remembered or saved passwords facilities must not be used on any computer used for council banking work. Breach of this Regulation will be treated as a very serious matter under these regulations
6.17	Changes to account details for suppliers, which are used for internet banking may only be changed on written hard copy notification by the supplier and supported by hard copy authority for change signed by two of the Clerk, the RFO, a member. A programme of regular checks of standing data with suppliers will be followed.
6.18	Any Debit Card issued for use will be specifically restricted to the Clerk and the RFO and will also be restricted to a single transaction maximum value of £500 unless authorised by council or FLAC in writing before any order is placed.
6.19	A pre-paid debit card may be issued to employees with varying limits. These limits will be set by the council. Transactions and purchases made will be reported to the council and authority for topping-up shall be at the discretion of the council.

6.20	Any corporate credit card or trade card account opened by the council will be specifically restricted to use by the Clerk and RFO and shall be subject to automatic payment in full at each month-end. Personal credit or debit cards of members or staff shall not be used under any circumstances.
6.21	The council will not maintain any form of cash float. All cash received must be banked intact. Any payments made in cash by the Clerk or RFO (for example for postage or minor stationery items) shall be refunded on a regular basis, at least quarterly.

9.1	The collection of all sums due to the council shall be the responsibility of and under the supervision of the RFO

9.9	Where any significant sums of cash (£200 or over) are received by the council, the RFO shall take such steps as are agreed by the council to ensure that more than one person is present when the cash is counted in the first instance, that there is a reconciliation to some form of control such as ticket issues, and that appropriate care is taken in the security and safety of individuals banking such cash.
9.10	Any income arising which is the property of a charitable trust shall be paid into a charitable bank account. Instructions for the payment of funds due from the charitable trust to the council (to meet expenditure already incurred by the authority) will be given by the Managing Trustees of the charity meeting separately from any council meeting (see also Regulation 19 below).

Copies of orders shall be retained.

11.1b	<p>Where the council intends to procure or award a public supply contract, public service contract or public works contract as defined by The Public Contracts Regulations 2015 (“the Regulations”) which is valued at £25,000 or more, the council shall comply with the relevant requirements of the Regulations<sup>1</sup>, including advertising the requirement, the procedure to be followed and the award of new contracts on the Contracts Finder website.</p> <p>The full requirements of The Regulations, as applicable, shall be followed in respect of the tendering and award of a public supply contract, public service contract or public works contract which exceed thresholds in The Regulations set by the Public Contracts Directive 2014/24/EU (which may change from time to time)<sup>2</sup>.</p>
11.1c	When applications are made to waive financial regulations relating to contracts to enable a price to be negotiated without competition the reason shall be embodied in a recommendation to the council.

11.1i	Should it occur that the council, or duly delegated committee, does not accept any tender, quote or estimate, the work is not allocated and the council requires further pricing, provided that the specification does not change, no person shall be permitted to submit a later tender, estimate or quote who was present when the original decision making process was being undertaken.
