- 19L/048. Election of Chairman Resolution to appoint Cllr Wilson as CALF Chair. RESOLVED.
- **19L/049.** Chairman's Introduction and Apologies Apologies accepted from Cllrs Hewitt (work) and Young (personal).
- 19L/050. Public participation Standing Orders to be suspended None present.

- **19L/052. Minutes** Resolution that the minutes of the Committee meeting held on the 16th April 2019 be signed as a correct record. **RESOLVED**.

19L/053. Reports

- Clerk report Report noted. Defib has been installed but is pending registration with ambulance service. Sign to be installed noting financial contribution from FECA. Cllrs Dewey, Kidston and Wilson to act as inspectors (needs weekly checks). Shower in changing rooms has been fixed. Mr Miles (Colts) arrived 7.36pm. Resolution to take out Connections Bus advert in CPS magazine at a cost of £50. RESOLVED. Colts have noted F2/F3 trip hazard (where cars/pedestrians will be during the tournament); groundsman to check. Mr Stuchbury arrived 7.39pm. Police have conducted environmental assessment of the Moat. Item to remove the benches has already been actioned and they have been moved to the tennis courts at the Rec. Defer other actions until September to see what result bench removal makes. Mr Raven to provide quote for Pound wall repairs. Clerk to check Japanese knotweed schedule.
- **Health & Safety reports** Report noted. Groundsman has repaired the hole by toddler area entrance. Roundabout edging work has been done. Slide step Clerk to contact Bridgeman Maintenance.
- Major developments Report noted. Open space discussions with This Land look promising.
- Village Hall & Nursery update Report noted. Currently trying to come up with ideas as to how to reduce costs by approx. £1m. Pros/cons of reducing Hall to single storey discussed. Will know more after the value engineering meeting this Thursday.
- Tennis Courts update Mrs Cook provided an update on the Tennis for Free event which was very well attended. For the Club to grow it requires at least 3 courts; possibility to add where existing containers are? Further grass improvements required and need to look at possible storage for small items. Ideally goals should be kept away from the courts to provide visibility during the playing season. Clerk to produce signs detailing contact/rules and also contact details for Tennis Club. Discussion regarding possibility of holding coaching sessions on Tuesday nights; this would have to be subject to a commercial agreement as per other clubs and own insurance would be required.
- Youth report Report noted. Summer sessions to be on Wednesday evenings.
